MINUTES OF MEETING

REGULAR MEETING OF THE PONTOON BEACH PUBLIC WATER DISTRICT WAS CALLED TO ORDER AT 7:00 p.m. BY CHAIRMAN CHRIS HANKINS. ROLL CALL OF BOARD MEMBERS: PRESENT—CHRIS HANKINS, CURT EDWARDS, WILLIAM ARNOLD, DOUGLAS CRITES, BEVERLY HOPPER, SCOTT SMALLIE, AND DISTRICT MANAGER TERRY KREHER. ABSENT: THOMAS HANSON.

BUSINESS:

CHRIS HANKINS ASKED BOARD MEMBERS IF ALL RECEIVED MINUTES OF MEETING ON FEBRUARY 1, 2017 BY E-MAIL. ALL RECEIVED. MOTION BY SCOTT SMALLIE TO ACCEPT THE MINUTES AS RECEIVED. SECOND BY BEVERLY HOPPER. ALL AYES, CARRIED.

ALL BOARD MEMBERS RECEIVED COPY AND STUDIED THE DISTRICT BILLS FROM FEBRUARY2, 2017 THRU MARCH 1, 2017. WILLIAM ARNOLD MADE MOTION TO PAY ALL BILLS AS PRESENTED FOR THE DISTRICT. SECOND BY SCOTT SMALLIE. ROLL CALL VOTE. UNANIMOUS.

OLDBUSINESS:

CHAIRMAN ASKED FOR REPORT ON DISTRICT INVESTMENTS. PRESENTED WITH RATES AND TIME PERIODS ON CERTIFICATE OF DEPOSITS FROM BANK OF EDWARDSVILLE AND FIRST NATIONAL BANK OF STAUNTON. DISCUSSION. BOARD REQUESTED A COMPARISON OF OUR WATER SALES REVENUES OVER THE PAST YEAR TO SEE THE FINANCIAL BALANCE DIFFERENCE. DISCUSSION. BOARD SUGGESTED GET BID FRAOM DELL FOR COMPARISON. WILL ASK MR. CHAPMAN TO ATTEND APRIL MEETING TO ANSWER ALL QUESTIONS. TABLED UNTIL APRIL MEEINTG.
